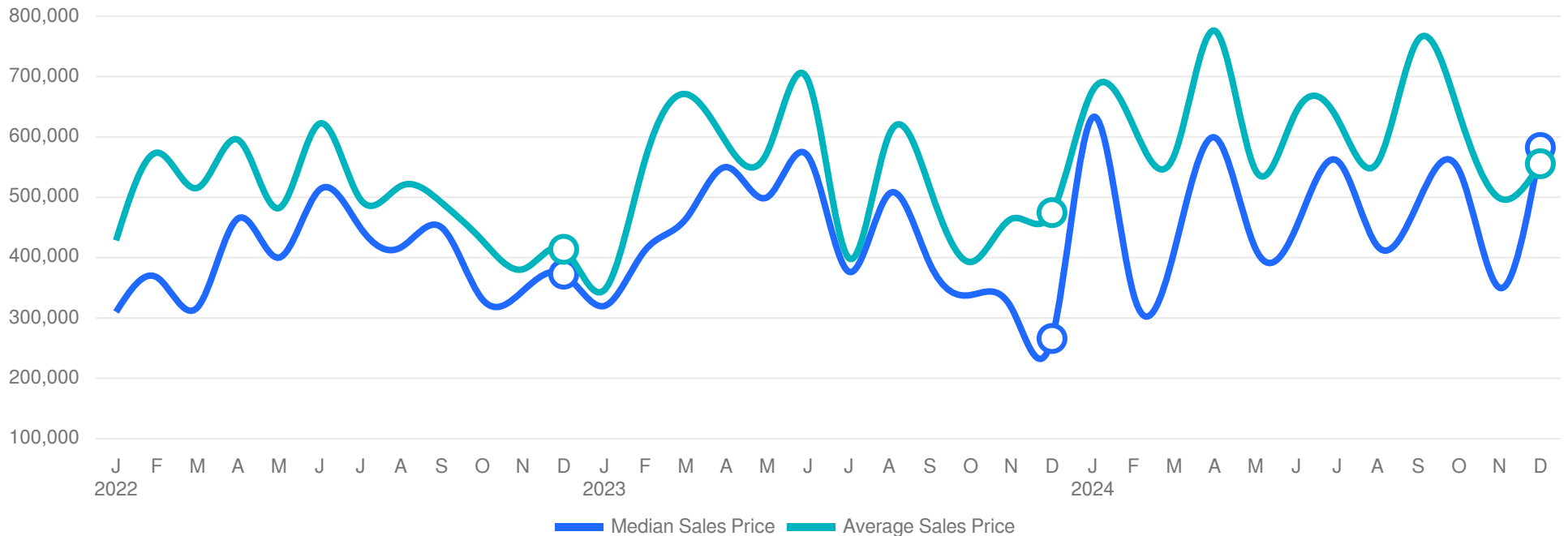

The median sales price in December 2024 was \$582,500, up 66.43% from \$350,000 from the previous month and 118.98% higher than \$266,000 from December 2023. The December 2024 median sales price was at its highest level compared to December 2023 and 2022. The average sales price in December 2024 was \$555,610, up 11.47% from \$498,446 from the previous month and 17.08% higher than \$474,556 from December 2023. 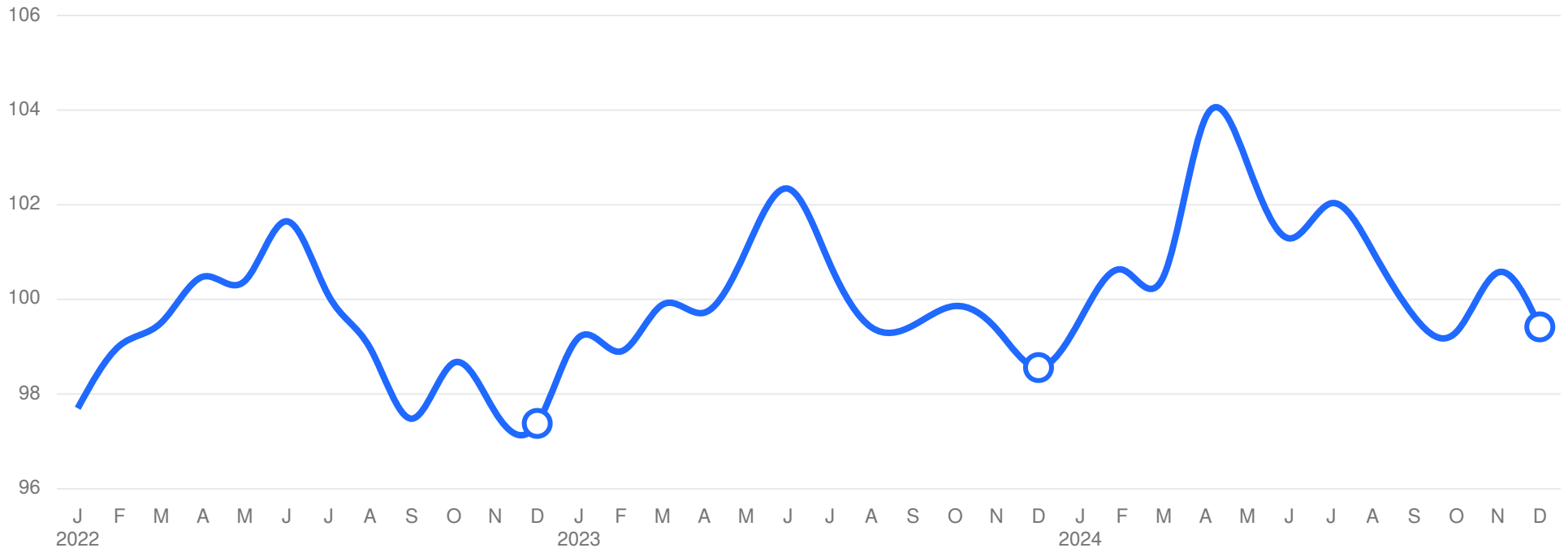

Sales Price / List Price Ratio

The sales price/list price ratio is the average sale price divided by the average list price for sold properties expressed as a percentage. If it is above 100%, homes are selling for more than the list price. If it is less than 100%, homes are selling for less than the list price. The December 2024 sales price/list price ratio was 99.42%, down from 100.57% from the previous month and equal to December 2023.

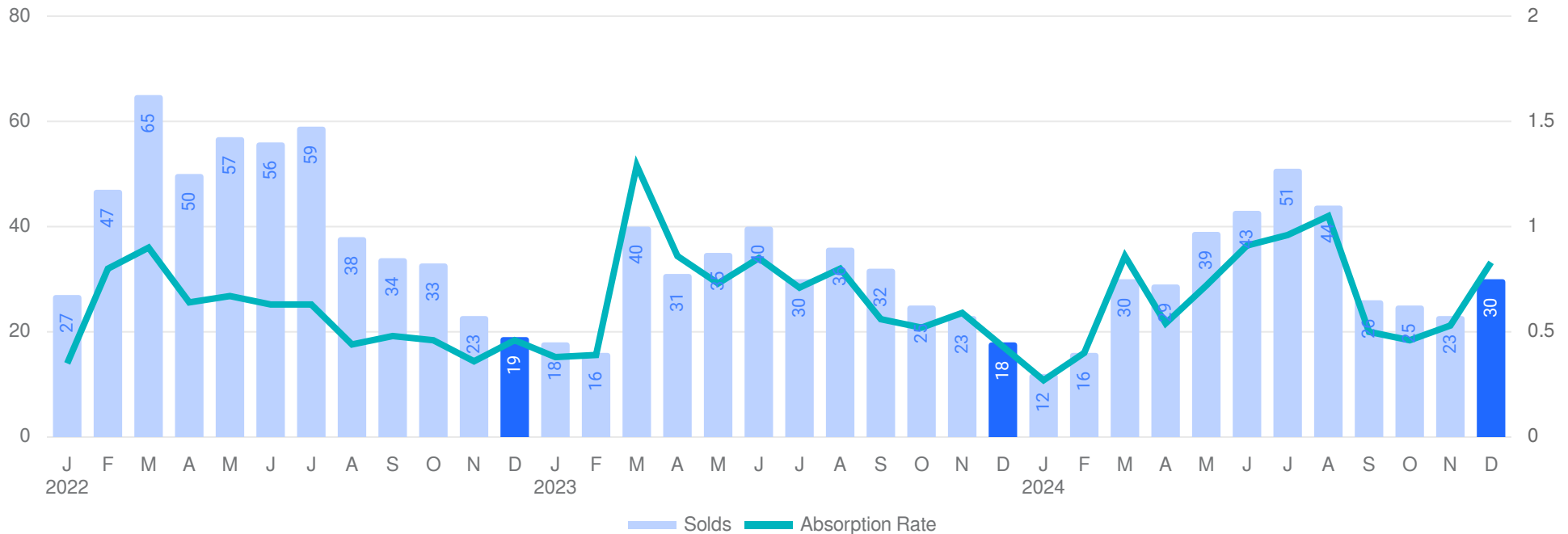

Number of Properties Sold & Absorption Rate

The number of properties sold in December 2024 was 30, up 30.43% from 23 from the previous month and 66.67% higher than 18 from December 2023. The December 2024 sales were at its highest level compared to December 2023 and 2022. Absorption rate is the avg number of sales per month divided by the total number of available properties.

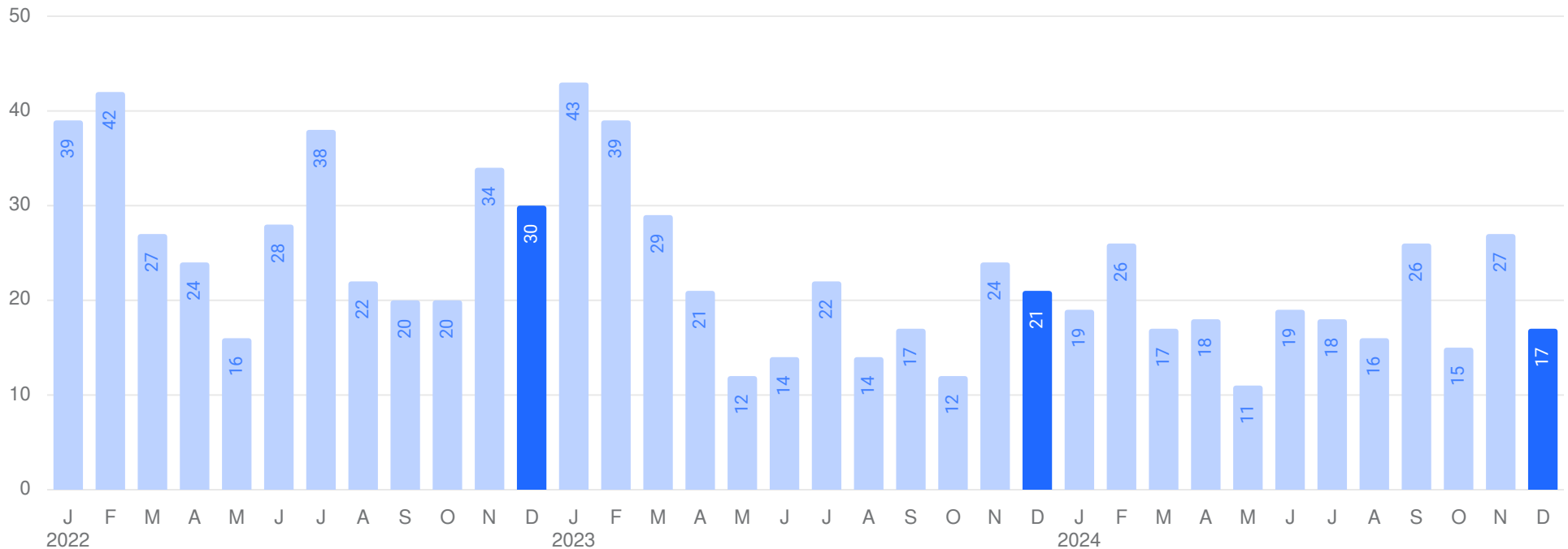

Average Days on Market

The average days on market (DOM) is the number of days a property is on the market before it sells. An upward trend in DOM tends to indicate a move towards a buyer's market, a downward trend tends to indicate a move towards seller's market. The DOM for December 2024 was 17 days, down -37.04% from 27 days from the previous month and -19.05% lower than 21 days from December 2023. The December 2024 DOM was at its lowest level compared with December 2023 and 2022.

Inventory & MSI

The number of properties for sale in December 2024 was 36, down -16.28% from 43 from the previous month and -14.29% lower than 42 from December 2023. The December 2024 inventory was at its lowest level compared with December 2023 and 2022. A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The December 2024 MSI of 1.2 months was at its lowest level compared with December 2023 and 2022.

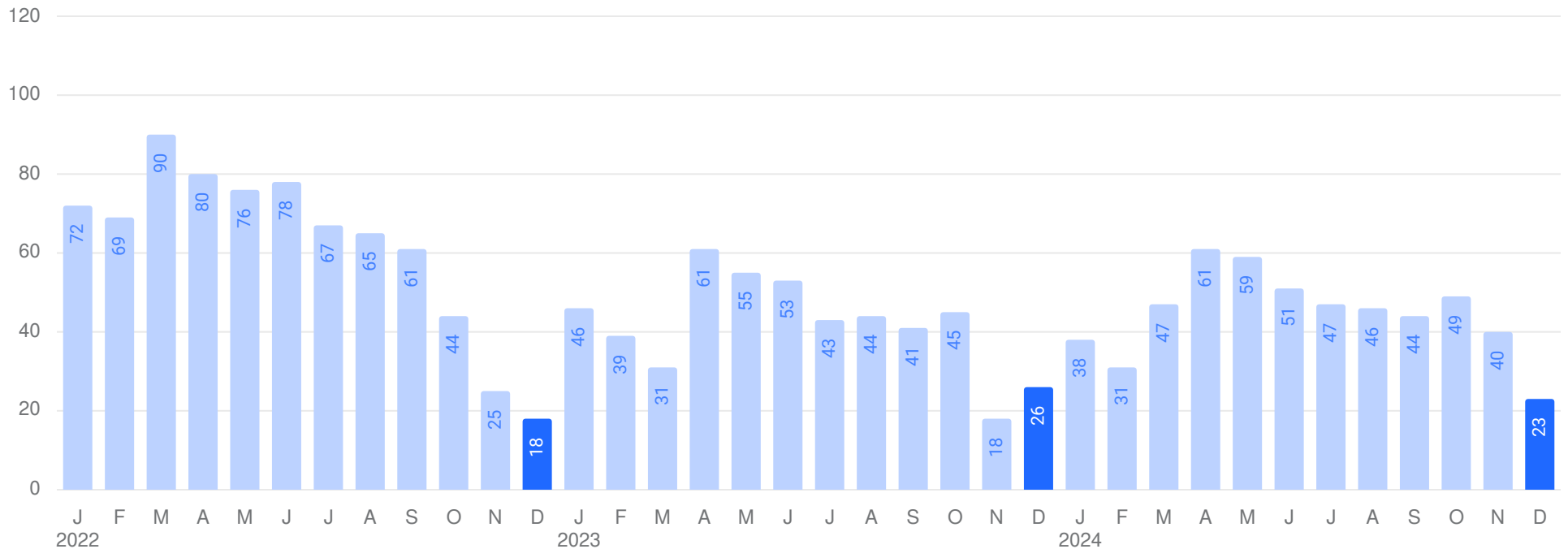
